GuruFocus.com, LLC does not provide personalized investment advice; all content, opinions and recommendations are impersonal and are not tailored to meet individual subscribers' investment needs. As part of our research subscription services, we have no access to, and therefore do not monitor, subscriber accounts. We do *not* limit the types of investments that we cover on GuruFocus.com. **Item 3: Fees, Costs, Conflicts, and Standard of Conduct**

**What fees will I pay?** Certain content on GuruFocus.com is free of charge. Subscription fees apply for Premium Membership, PremiumPlus Membership, and Professional Membership which are available in an annual or monthly payment plan. Terms of service, subscriber rights, and restrictions are specified in the "Terms of Use" which are available on GuruFocus.com. The fees shown below cover a single Membership. An annual discount is applied for each region added to the annual Premium and PremiumPlus Memberships. Fees may be subject to change with advance notice in accordance with the Terms of Use. Premium Membership subscription fees are \$499/year for US market, \$449/year for Asian market, and \$449/year for EU market. PremiumPlus Membership subscription fees are \$1,348/year for US market. Professional Membership annual subscription fees are \$2,398/year for US market. An additional annual fee is applied for each global region selected.

Subscription fees are payable annually or monthly in advance. Most subscribers pay by credit card, although in limited cases may pay by check, wire, or ACH. Premium and PremiumPlus Membership subscriptions automatically renew on the anniversary date of the original subscription date, unless terminated by the subscriber prior to the renewal date. GuruFocus.com offers a 7-day trial period at no cost to new subscribers. The paid Membership subscription period begins the day following the last day of the trial period, if applicable. Thereafter, if the subscription is canceled within six (6) months of the start date of the subscription, any pre-paid subscription fees are refunded pro rata for the number of days remaining in the subscription period. If the subscription is canceled after the 6-month period has passed, there is no refund due the subscriber, while access to paid content will continue until the last day of the subscription period. Subscribers may cancel their subscription within 30 days and receive a full refund.
